Dear Valued Customer:

The Bank & Trust of Bryan/College Station will complete our systems integration with First Financial Bank over the weekend of April 17<sup>th</sup>. The purpose of this letter is to convey key points you will need to know as further detailed in the enclosed New Account Guide and Schedule of Fees.

- These changes take effect automatically on **April 20<sup>th</sup>** and **will require no action on your part.**
- However, you may see some differences between your current account type (as reflected on your monthly account statement) and your new account type. The enclosed New Account Guide has an easy account conversion table detailing the features and benefits of your new account. If, after reviewing the account information or receiving your statement, you believe another account type might better meet your needs, please feel free to contact your officer or come by any branch location and visit with a personal banker and we will find solutions to meet your needs.
- Important details about our Overdraft Privilege Program that protects you against small, inadvertent errors are also enclosed.
- Your base account number will not change. However, the Bryan/College Station Region number of **19**, along with additional zeros, will be added to the front of the base account number equal to 12 digits. *For example, if your current account number is 1234567, your expanded account number would be 190001234567.*
- Do not be concerned about this expansion of account numbers. Your existing checks and deposit slips are fine to use "as is" until your next reorder and there is nothing you need to do regarding existing direct deposits or automatic drafts. However, please use your expanded 12-digit account number and new routing number 111301122 for future check reorders, wire transfer, and when setting up future direct deposit and automatic drafts beginning April 20<sup>th</sup>.
- You will receive two (2) statements during the month of April.
  - The first will occur on April 17<sup>th</sup> and, if applicable, show interest paid from your prior statement date through April 17<sup>th</sup>. It will be generated in paper format only but should be available electronically by the end of April.
  - The second statement will generate on your regular statement cycle date, either electronically or in paper as you have opted. Your expanded 12-digit account number will be reflected on this second statement.
- Online banking customers will receive a separate communication with important timelines.
- If you currently have a debit card, you will receive a new card with a new debit card number and a separate mailing with your PIN. Instructions regarding activation will be provided in a letter accompanying the card.
- If you are a Cash Management customer, either Shane Greeley, Tim Murphy or other members of our Treasury Management team will contact you soon to assist in the transition of your services.
